Dear Mr. Srivastava,

You are aware that Ministry of Labour & Employment has been operating the Centrally Sponsored Plan Scheme for Rehabilitation of Bonded Labour since 1978. The scheme was revised in May, 2000 to include survey of bonded labourers, awareness generation activities and evaluatory studies in the scheme. Under the scheme, an amount of Rs. 2 Lakhs per district is provided to the State Government concerned for conducting survey of identification of bonded labour in each sensitive district. The survey for identification is conducted in a district once in 3 years.

2. I would like to bring to your notice that central assistance amounting to Rs.18 lakh, for conducting survey of bonded labour was provided to your state in the year 2004-05 but a report of the survey has not been received as per the requirement of the scheme.

3. This issue has also been adversely commented upon by the Hon'ble Supreme Court in its order dated 01.10.2010 in Writ Petition No. 3922 of 1985 which is reproduced below:-
"It appears from the Note submitted by the Amicus Curie that the States/Union Territories are receiving a sum of Rupees two Lakhs per District per three years. We have requested the Solicitor General to assist the Court in submitting the data as to the amount, which the Centre is releasing to the States/Union Territories and whether the States/Union Territories are in fact using the amount for which they are released."

4. I shall request you to send survey reports and utilization certificate in respect of the survey conducted immediately to this Ministry so that the Hon'ble Supreme Court is apprised accordingly.
