**Sub : Release of labourers under Bonded Labour Abolition Act, 1976.**

Kind reference is invited to the subject mentioned above. In this regard, it is to state that on complaint of Bandhuwa Mukti Morcha and after due inquiry vide Order dated 23/01/2010 of SDM (Najafgarh) 16 labourers from Chhattisgarh were released from the aegis of Sanjeev Malhotra of Best Buildwell P. Ltd. and Sub-Contractor Manzoor Alam @ Kalloo. The said labourers were working for the above mentioned contractors in Sector-18 of Dwarka, District South-West, Delhi.

Out of 16, 07 labourers left Chhattisgarh of their own and the remaining 09 labourers were provided an interim relief of Rs. 1,000/- each (List of labourers attached) from the Office of Deputy Commissioner (South-West), Delhi thereafter through assistance of Bandhuwa Mukti Morcha the labourers were deported to their native Districts in Chhattisgarh (List of the labours enclosed). Out of the 9 labourers deported three are reportedly residents of Bilaspur District and remaining six are from Jhanjgir Champa.

In light of the above, you are requested to kindly take necessary measures for rehabilitation of these labourers so that they did not fall in the depth trap and the clutches of unscrupulous contractors.


